

- 8. You will be given a BUZZ'S identification bracelet and you are required to wear it 24/7 everyday of the tour. Failure to wear the bracelet will result in a 50.00 Euro fine and possible termination from the tour & NO refund..
- 9. Shoplifting, graffiti, vandalism, fighting, public drunkenness and possession of illegal drugs are extremely dangerous Abroad and you may be kicked off the tour with NO refund.
